I, the undersigned participant in the Oneness Awakening Course described below (the "Course"), hereby acknowledge that I have apprised myself of the nature of, and activities in which I will participate during, the Course.

To further the success of the Course, help ensure the continuation of these and similar Courses, in consideration of my acceptance to the Course, and for other good and valuable consideration, I represent, warrant and agree, as follows:

- 1. My decision to attend the Course is based solely on my personal experience thus far with the Oneness Blessing®. My attendance at the Course is for the sole and exclusive benefit of my own personal development, and I affirm that I freely and voluntarily choose to participate in the Course. No promises or warranties of any benefits or particular results have been made to me or have influenced me to enter into this agreement or participate in this Course. I shall comply with all Course rules and regulations, and will conduct myself in a manner that will not disrupt the smooth functioning of the Course.
- 2. I am presently in good mental and physical health. I understand that the Oneness Blessing and any other aspects of the Course are not a substitute for professional medical treatments for physiological or psychological complaints and do not constitute advice on medical or psychological treatments. I agree that I shall, at my own expense, obtain any appropriate medical treatment that may be necessary while I am attending the Course. If the Oneness Trainers ("Trainers") leading the Course determine in their discretion that a medical emergency exists, I authorize them to obtain medical treatment for me at my expense.
- 3. I understand that the Oneness Blessing and participation in the Course do not require the acceptance of any belief or lifestyle. I agree that the Course is an educational process and that maximum benefit is gained when participants freely and fully examine for themselves the ideas presented and evaluate these ideas in light of their own understanding and experience.
- 4. I agree that the Trainers offering the Oneness Blessing and the Course are individuals dedicated to benefitting the individual, society and the world through their Oneness-related activities, and that all of their resources and energy devoted to these activities are used to fulfill these valuable purposes. I desire to ensure that the activities of these Trainers and the Oneness Blessing Givers who work on their behalf are not hindered by the expense and other burdens involved in defending legal proceedings. I agree to take full responsibility for my participation in the Course and the results arising from such participation. I agree not to bring any legal actions against these Trainers or Oneness Blessing Givers, Oneness University India (the "Organization") or any affiliated organizations (collectively, the "Parties") for any negligent or non-intentional acts or omissions, and I release the Parties, their agents, employees and Oneness Blessing Givers from all such claims and damages, and for all breaches of express and implied warranties (including warranty of merchantability). Any of the Parties shall be entitled to enforce this provision of the Agreement by injunctive relief as well as be entitled to any other legal or equitable remedy.
- 5. If the refund policy of this Course entitles me to a refund, I understand that if I do not send a refund request to the office through which I applied by the Course beginning date, the course fee is not refundable. I agree to

promptly withdraw from the Course if for any reason the Trainers conducting the Course decide, in their sole discretion, that such withdrawal is advisable. I understand that the course fee will not be refunded in case I am asked to leave the Course because of my mode of conduct or in case I leave the Course without the consent of the Trainers conducting the Course. In case I have to leave the Course for reasons of health, I understand that it will be possible to complete the Course only if the same Course is available at some other time and location, and only if it is considered desirable according to the judgment of the Trainer conducting the Course. I will be informed by the Trainer if and when the opportunity to complete the Course arises.

- 6. I represent that everything that I have expressed in my Course application and in this Agreement is accurate and true, and I agree to compensate and indemnify the Parties for any loss or damages, including attorneys' fees, and other expenses that may arise from any false representations made in this Agreement by me, or from my breach of any other provisions of this Agreement. I further agree that any violation of this Agreement by me may result in the immediate termination of my rights described in Section 8 hereof and my ability to participate in courses or programs offered by the Trainer, the Organization or their affiliates. All of the representations, warranties and agreements that I have made in this Agreement may be relied upon and/or enforced by any of the Parties.
- 7. I understand that attending the Course does not ensure that I will be initiated as a Oneness Blessing Giver and that my initiation as a Oneness Blessing Giver at the end of the Course or at any later time is completely within the sole discretion of the Trainers conducting the Course. If I am initiated as a Oneness Blessing Giver, I agree to comply with all Oneness Blessing Giver Guidelines established by the Organization, as amended from time to time in the sole discretion of the Organization.
- 8. If, as part of the Course, I am initiated as a Oneness Blessing Giver or I have previously been initiated as a Oneness Blessing Giver, then to protect the purity of the Oneness Blessing, I hereby agree as follows:
- 8.1 The Oneness Blessing refers to all unique names, information, methods, compilations, techniques, processes, principles, programs, procedures, compositions, modes of production, process and product applications and uses, and products, relating to the offering and knowledge of the Oneness Blessing.
- 8.2 The owner of all trademarks and service marks ("Marks") related to the Oneness Blessing is For World Peace Pte. Ltd., a Singapore corporation (the "Owner"), which is affiliated with the Organization. The Marks include those used by the Organization at any time, including, but not limited to those listed (as modified from time to time) on any Website maintained by the Organization from time to time.
- 8.3 The Owner hereby grants to me, as a Oneness Blessing Giver, permission to use the Marks, provided however, that such permission is limited to use in connection with activities the Owner, the Organization or their affiliates, either directly or through an authorized Trainer, authorize me from time to time to conduct as a Oneness Blessing Giver, and I agree to use the Marks only in conformity with standards and guidelines provided by the Owner, the Organization or their affiliates, either directly or through an authorized Trainer.
- 8.4 I expressly recognize and acknowledge that all use of the Marks and goodwill connected therewith shall inure to the benefit of the Owner. Further, I acknowledge that I have not acquired and will not acquire any right, title, interest or claim of ownership in the Marks, except for the purposes of this Agreement.
- 8.5 I acknowledge that the Marks have a valuable reputation, and a distinctive meaning to the public. Therefore, I will at no time during or subsequent to this Agreement alter, modify or dilute the Marks, bring them into disrepute, or make use of them other than as provided in this Agreement. I shall not, at any time, use any name confusingly similar to or in the reasonable judgment of Owner, the Organization or any of their affiliates suggestive of the Marks.
- 8.6 Upon termination of my status as a Oneness Blessing Giver hereunder, I shall immediately (i) cease any use of the Marks associated with the Oneness teachings and the Oneness Blessing, (ii) at my own expense, return to the Trainer or the Organization or its affiliates all materials in my possession or accessible to me that reference, concern, identify, embody, or otherwise relate to the Marks or the Oneness teachings, and (iii) turn over to

the Trainer or the Organization or its affiliates all email addresses, mailing addresses, telephone numbers, and other contact information relating to my activities as a Oneness Blessing Giver.

In the event of any violation of the terms of this Section 8, Owner, its affiliates and any authorized Trainer shall be entitled to an injunction, and other equitable relief, to prevent a breach of this Agreement in addition to any damages to which such party may be entitled.

- 9. If, as part of the Course, I am initiated as a Oneness Blessing Giver or I have previously been initiated as a Oneness Blessing Giver, then by written notice at any time thereafter, the Trainer or the Organization may terminate my right to act as a Oneness Blessing Giver due to any actions I take that the Trainer or the Organization or its affiliates, in his, her or its sole discretion, deems (i) to be inconsistent with the purposes of the Agreement, (ii) to affect my ability to offer the Oneness Blessing or (iii) to undermine the public's respect and trust of the Trainer or the Organization. Upon such termination, I shall continue to be bound by this Agreement in all respects, provided, however, that the rights conferred upon me in Section 8.3 shall cease and I shall thereafter have no right to use the Marks in any manner whatsoever.
- MEDIATION AND ARBITRATION: If any issue or claim arises between the parties, both agree to seek in good faith to resolve such issue or claim through negotiation using, if necessary, the assistance of a mutually agreed upon third party mediator. If such negotiations are not successful, any controversy or claim arising out of or relating to this Agreement or any breach or default under this Agreement, shall, with respect to all claims pertaining to such controversy, claim, breach, or default (except any action for equitable relief with respect thereto), be settled by arbitration in a state determined by the Trainer, on a confidential basis, by arbitration before a single arbitrator selected in accordance with the then-prevailing Rules of Commercial Arbitration of the American Arbitration Association. The arbitrator shall have the discretion to determine the appropriate scope and schedule of discovery. The arbitrator shall not contravene or vary in any respect any of the terms or provisions of this Agreement. The award of the arbitrator shall be final and binding upon the parties hereto, and judgment upon any award rendered therein may be entered and enforced in any court of competent jurisdiction. Neither this arbitration provision nor a pending arbitration shall prevent a party from seeking or obtaining injunctive relief for any matter at any time.
- 11. I agree that this Agreement can only be changed by a written modification signed by both parties. If any provision of this Agreement is found to be invalid, this shall not affect the validity of the remaining provisions. I hereby agree that I may not assign my rights and obligations under this Agreement to any party but that all rights herein that accrue to the Trainer shall accrue also to the Organization or its affiliates.
- 12. I have read and understand everything in this Agreement, and I intend to be legally bound by this Agreement.
